Borrower and Lensier coverient and agree as follows:

- 1. Paymont of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indabtedness evidenced by the flote, and late and other applicable charges as provided in the Note.
- 2. Application of Payments. Links replicable law on the Note provide otherwise, all payments received by Lender this Note and Paragraph 1 historists be applied by Lender first to interest payable on amounts disbursed by Lender under Paragraph 6, then to principal of the amounts disbursed by Lender under Paragraph 6, then to interest payable on the Note, and then to the Principal of the Note.
- 3. Chargest Liens. - 4. Hazard Insurance. - 11. Remedies Cumulative. All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this Mortgage or afforded by law or equity, and may be exercised concumunity, independently or successively.
- 12. Successors and Assigns Bound; Joint and Several Liability; Captions. The covenants and agreements increis contained shall bind, and the rights hereunder shall insure to, the respective successors and assigns of Lender and Borrows; subject to the provisions of Paragraph 16 hereof. All covenants and agreements of Borrower shall be joint and saveful. The captions and headings of Paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions horsof.
- 13. Notice. Except for any notice required under applicable law to be given in another manner, (a) any notice to Economic provided for in this Mortgage shall be given by mailing such notice by certified mail addressed to Borrower at the Property Address or at such other address as Borrower may designate by notice to Lender as provided herein, and (b) any notice to Lender shall be given by certified mail, return receipt requested, to Lender's address stated therein or to such other address as Lender may designate by notice to Borrower as provided herein. - 14. Uniform Mortgage; Governing Laws; Severability. This form of mortgage combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property. This Mortgage shall be governed by the law of the jurisdiction in which the Property is located. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of the Mortgage and the Note are declared to be severable.
- 15. Borrower's Copy. Borrower shall be furnished a conformed copy of the Note and of this Mortgage at the time of execution or after recordation hereof.
- 16. Transfer of the Property: Assumption. If all or any part of the Property or an interest therein is sold or transferred by Borrower without Lender's prior written consent, excluding (a) the creation of a lien or encumbrance subordinate to this Mortgage, (b) the creation of a purchase money security interest for household appliances. (c) a transfer by devise or descent or by operation of law upon the death of a joint tenant or (d) the grant of any leasehold interest of three years or less not containing an option to purchase, Lender may at Lender's option, declare all the sums secured by this Mortgage to be immediately due and payable.
