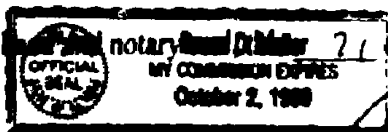

The tenant of Unit 2L has waived or has failed to exercise the right of first refusal.

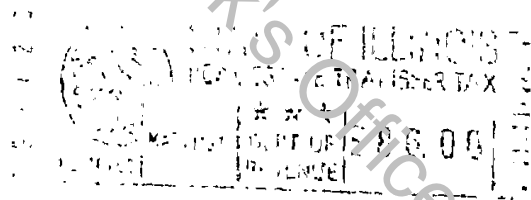
