Subject to any declarations, calculous or rest icid in third or a schedule of two plions th coverage in any title insurance policy insuring Mortgagor's interest in the Premises, Mortgagor covenants that (i) Mortgagor is lawfully seized of and has the right to mortgage, grant and convey the Premises, (ii) the Premises are unencumbered and (iii) Mortgagor will warrant and defend the title to the Premises against all claims and demands.

IT IS FURTHER UNDERSTOOD THAT:

- 1. Mortgagor shall promptly pay when due (i) the principal and interest due under the Note, (ii) prepayment and late charges as provided in the Note and (iii) the principal and interest on any future advances secured by this Mortgage.
 - 2 In addition, the Mortgagor shall:
 - (i) Promptly repair, restore or rebuild any improvement now or hereafter on the Premises which may become damaged or destroyed.

 - (iii) Keep the improvements now existing or hereafter constructed on the Premises insured against loss or damage by fire, lightning, wind storm or such other hazards as the Mortgagee may reasonably require to be insured against under policies providing for payment by the insurance companies of monies sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby.  - (v) Complete within a reasonable time any buildings or improvements, now or at any time hereafter, is the process of being constructed upon the Premises.
 - (vi) Keep the Premises (1) in good condition and repair, (2) without waste and (3) free from any and all mechanics' lien(s) and/or other lien(s) or claim(s) of lien which is/are not expressly subordinated to the lien hereof.
 - (vii) Not suffer or permit any unlawful use of or nuisance to exist on the Premises nor diminish or impair its value by any act or omission.

In the case of a failure to perform any of the covenants herein, or if any action or proceeding is commenced which materially affects Mortgagee's interest in the Premises, including, but not limited to, eminent domain, insolvency, code enforcement or arrangements or proceedings involving a bankrupt or decedent, the Mortgagee may do on the Mortgagor's behalf everything so covenanted; the Mortgagee may also do any act it may deem necessary to protect the lien hereof.  - (ii) Proceedings are instituted to enforce any other less or charge upon any of the Premises.
 - (iii) The Mortgagor makes an assignment of the Premises for the benefit of its creditors.
 - (iv) The Premises are placed under the control or in custody of 2.7 court or government officer.
 - (v) The Mortgagor abandons the Premises.
 - (vi) The Mortgagor fails to pay when due any charge or assessment (whether for insurance premiums, maintenance, taxes, capital improvements, purchase of another unit or otherwise) imposed by any condominium, townhouse, cooperative or similar owners' group.
 - (vii) The Mortgagor makes any misrepresentation(s) to the Mortgagee, including but not limited to any misrepresentation(s) made in this Mortgage.
- 7. Without the prior written approval of the Mortgagee, any sale, conveyance or transfer of any right, title or interest in the Premises (or any portion thereof) or any sale, transfer or assignment of all or any part of the beneficial interest of any trust holding title to the Premises shall constitute a default hereunder; and upon any such default, the Mortgagee or the holder of the Note may declare the entire indebtedness evidenced by said Note to be immediately due and payable and may foreclose this Mortgage immediately or at any time during which such default continues.

8. Upon the commendate of a violetic are protesting her conder, the cour in which such action is filed may at any time before or after sale, without notice to the Mortgagor or any party claiming under the Mortgagor, and without regard to the solvency of the Mortgagor or the then value of the Premises, and regardless of whether the Premises are then occupied by the owner of the equity of redemption as a homestead, appoint a receiver with power to manage, rent and collect the rents, issues and profits of said Premises during the pendency of the foreclosure, including the statutory period of redemption. Said rents, issues and profits, when collected, may be applied, before as well as after the foreclosure sale, towards (i) the payment of the indebtedness evidenced by the Note, costs, taxes, insurance or other items necessary for the protection and preservation of the Premises, including the expenses of the receivership or (ii) any deficiency judgment, whether in personam or not. If a receiver shall be appointed, said receiver shall remain in possession of the Premises until the expiration of the full period allowed by statute for redemption and in case of sale, until the issuance of a deed, but if no deed is issued, until the expiration of the statutory period during which it may be issued. No lease of said Premises shall be nullified by the appointment or entry in possession of a receiver, but said receiver may elect to terminate any lease junior to the Mortgage lien.

Upon foreclosure of the Premises, there shall be allowed and included as an additional indebtedness in the decree of sale all expenditures and expenses, together with interest thereon at the rate of 2% per annum above the Note rate then in effect, incurred by or on behalf of the Mortgagee for attorneys' fees, Mortgagee's fees, appraiser's fees, court costs and the estimated costs to be expended after the entry of the order or decree of foreclosure, including costs of procuring all such data with respect to title as Mortgagee may reasonably deem necessary to prosecute such suit or to evidence to bidders at any sale held pursuant to such order or decree the true title to or value of the Premises. In the event of a foreclosure sale of the Premises, there shall first be paid out of the proceeds thereof all of the aforesaid items; then the entire indebtedness, whether or not due and payable by the terminoreof, with interest thereon up to the time of such sale, shall be paid to the Mortgagee and the remainder, if any, shall be paid to the Mortgagor. The purchaser shall not be obligated to see to the application of the purchase money.

- The Mortgagee may grant and may refuse to grant any modification(s), extension(s), release(s), and/or reamortization(s), as set forth below, without the concent of the Mortgagor or the Mortgagor's successor(s) in interest. If the payment of the indebtedness hereby secured, or any part thereof, he extended or varied, or if any part of the security or guaranties therefor he released, all persons now or at easy time hereafter liable therefor or interested in the Premises, shall be held to assent to such extension, variation or release, and their liability hereunder, and the lien and all provisions hereof, shall continue in full force and effect; the right of recourse against all such persons being expressly reserved by Mortgagee, notwithstanding any such extension, variation or release. Neitlier the Mortgagor or any successor to the Mortgagor will be released in any manner from the liabilities of this Mortgage or the Note as a result of the Mortgagee's (i) modification of, (ii) reamortization of and/or (iii) extension of the time for payment of the indebtedness secured hereby. Any forbearance by Mortgagee in exercising any right or remedy hereunder or otherwise afforded by applicables law or in equity, shall not be a waiver of or preclude the exercise of any such right or remedy. Further, Mortgagor covenants and agrees that within five (5) calendar days of its receipt of a citation, notice of violation or other notice of potential liability from any governmental or quasi-governmental authority empowered to regulate or oversee any and/or all of the Environmental Requirements. Mortgagor shall deliver a copy thereof to Mortgagee.
