- If the registered office is manged from one county to another, then the corporation must file with the recorder of deeds of the new county a cartifled copy of the articles of incorporation and a certified copy of the statement of change of registered office Such certified copies may be obtained ONLY from the Secretary of State.
- Any change of registered agent must be by resolution adopted by the board of directors. This statement must then be signed by the president (or vic a-president) and by the secretary (or an assistant secretary).
- The registered agent may report a change of the registered office of the corporation for which he or she is ge,
