- 4. Phor Mortgages: Charges; Ligns. You shall parform all of your obligations under any mortgage, dead of trust or other security instruments with a lian which has priority over this Mortgage, including your covenants to make payments when due. You shall pay all taxes, assessments, charges, lines and impositions attributable to the Property which may attain priority over this Mortgage, and leasehold payments or ground rents, if any. Insurance proceeds shall be applied to restore or repair the Property damaged, if restoration or repair is aconomically feasible and our security would not be lessened. The 30-day period will begin when notice is given. Any application of proceeds to principal shall not require us to extend or postpone the due date of monthly payments. These amounts shall bear interest from the disbursement date at the rate established under the Note and shall be payable, with interest, upon our request. If we required mortgage insurance as a condition of making the loan secured by this Mortgage, you shall pay the premiums for such insurance until such time as the requirement for the insurance terminates.
 - 5. Inspection. We may inspect the Property at any reasonable time and upon reasonable notice.
- 9. Condemnation. The proceeds of any award for damages, direct or consequential, in connection with any condemnation or other taking of any part of the Property, or for conveyance in lieu of condemnation, are hereby easigned and shall be paid to us.
