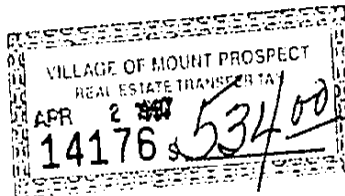

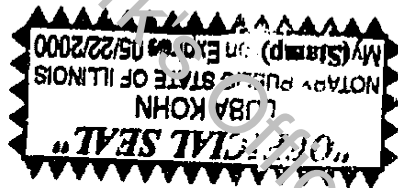

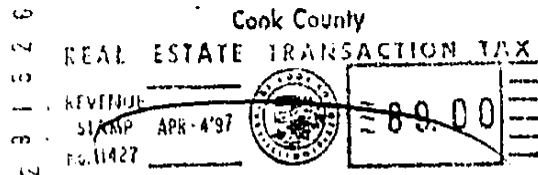
Parcel 2:

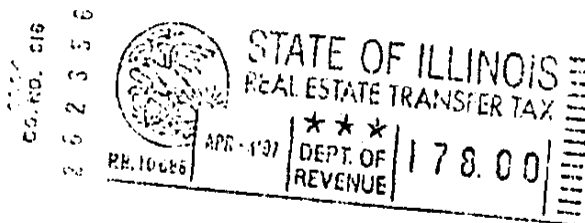
