THIS MORTGAGE IS DATED APRIL 4, 1997, between American Midwest Bank & Trust, as Trustee U/T/A dated March 20, 1997 and known as Trust #6671, and not personally, whose address is 1600 W. Lake St., Melrose Park, IL 60160 (referred to below as "Grantor"); and American May st Bank & Trust, whose address is 1600 W. Lake Street, Melrose Park, IL 60160 (referred to below as "Lende ").

GRANT OF MORTGAGE. Personal Property. The words "Personal Property" mean all equipment, fixubes, and other articles of personal property now or hereafter owned by Grantor, and now or hereafter attached or affixed to the Real Property; together with all accessions, parts, and additions to, all replacements of, and all substitutions for, any of such property; and together with all proceeds (including without limitation all insurance proceeds and refunds of premiums) from any sale or other disposition of the Property.

Property. The word "Property" means collectively the Real Property and the Personal Property.

Real Property. The words "Real Property" mean the property, interests and rights described about it the "Grant of Mortgage" section.

Related Documents. The words "Related Documents" mean and include without limitation all promise or notes, credit agreements, loan agreements, environmental agreements, guaranties, security agreements, mortgages; deeds of trust, and all other instruments, agreements and documents, whether now or hereafter existing, executed in connection with the Indebtedness.

Rents. The word "Rents" means all present and future rents, revenues, income, issues, royalties, profits, and other benefits derived from the Property.

THIS MORTGAGE, INCLUDING THE ASSIGNMENT OF RENTS AND THE SECURITY INTEREST IN THE RENTS AND PERSONAL PROPERTY, IS GIVEN TO SECURE (1) PAYMENT OF THE INDEBTEDNESS AND (2) PERFORMANCE OF ALL OBLIGATIONS OF GRANTOR UNDER THIS MORTGAGE AND THE RELATED DOCUMENTS. Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all Improvements on the Real Property in an amount sufficient to avoid a pleation of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. Grantor shall also precure and maintain comprehensive general liability insurance in such coverage amounts as Lender may require and maintain such other insurance, including but not limited to hazard, business interruption and builer, insurance as Lender may require. Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property if the estimated cost of repair or replacement exceeds \$1,000.00. Lender may make proof of loss if Grantor fails to do so within fifteen (15) days of the casualty. Whether or not Lender's security is impaired, Lender may, at its election, apply the proceeds to the reduction of the Indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Grantor shall repair or replace the damaged or destroyed Improvements in a manner satisfactory to Lender. Lender shall, upon satisfactory proof of such expenditure, pay or reimburse Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default hereunder. Attorneys' Fees; Expenses.
