1. Mortgagors shall (a) promptly repair, restore and rebuild any buildings or horrovements now or hereafter on the	
premises which may become damaged or be destroyed; (b) keep said premises in 1001 condition and repair, without	
waste, and free from mechanic's or other liens or claims for lien not expressly subordivated to the lien hereof; (c) pay

2. 10. Upon, or at any time after the filing of a bill to foreclose this trust deed, the court in which such bill is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of the Mortgagors at the time of application for such receiver and without regard to 83 the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder. may be appointed as such receiver. Such receiver shall have the power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory (D) period of redemption, whether there be redemption or not, as well as during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management, and operation of the premises during the whole of said period.

12. Trustee or the holders of the notes, or of any of them, shall have the right to inspect the premises at all reasonable

times and access thereto shall be permitted for that purpose.

Trustee has no duty to examine the title, location, existence, or condition of the Premises, or to inquire into the validity of the signatures or the identity capacity, or authority of the signatures on the note or the trust deed, nor shall Trustee be obligated to record this trust deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or omissions hereunder, except in case of its own grows negligence or misconduct or that of the agents or employees of Trustee, and it may require indemnities confidency to it before exercising any power herein given.

- 15. Trustee may resign by instrument in writing filled in the office of fine Reporter of Deeds in which this instrument shall have been recorded or filed. Any Successor in Trust leaves that there the identical title, powers and authority as are herein given Trustee.

This Trust Deed and all provisions hereof, shall as the to the binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used notein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the principal notes or this Trust Deed.
- 17. Before releasing this trust deed, Trustee or successor trustee shall receive for its services a fee as determined by its rate schedule in effect when the release deed is issued. Trustee or successor trustee shall be entitled to reasonable compensation for any other act or service performed under any provisions of this Trust Deed.
