Should the Reat Property at any time become located in an area designated by the Director of the Federal Emergency Management Agency as a special flood hazard area, Grantor agrees to obtain and maintain Federal Flood Insurance for the full unpaid principal balance of the loan, up to the maximum policy limits set under the National Flood Insurance Program, or as otherwise required by Lender, and to maintain such insurance for the term of the loan.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or dainage to the Property if the estimated cost of repair or replacement exceeds \$5,000.00. | losses and expenses of any nature, in connection with the execution of this instrument, shall be construed as only a right of |
| redemption out of the assets of the Trust. Notwithstanding anything in this instrument contained, in the event of any conflict |
| between the body of this exoneration and the body of this instrument, the provisions of this paragraph shall control. Trustee |
| being fully exempted, nothing herein contained shall limit the right of any party to enforce the personal liability of any other |
| party to this instrument. |
