- 7. Protection of Lender's Security. If Sorrower falls to perform the covenants and agreements contained in this Mortgage, or if any action proceeding is commenced which materially affects Lender's interest in the Property, then Lander, at Lender's option, upon notice to Borrower, ay make such appearances, disburse such sums, including reasonable attorneys' fees, and take such action as is necessary to protect Lender's
