- 1. ASSIGNMENT. - 8. GRANTOR MAY RECEIVE RENTS. As long as there is no default under the Note described above, the Mortgage securing the Note, this Agreement or any other present or future obligation of Borrower or Grantor to Lender ("Obligations"). - 6. DEFAULT AND REMEDIES. Upon delault in the payment of, or in the performance of, any of the Obligations.
