I will make a final balloan payment of the remaining unpaid interest or other charges. To the extent recentited by applicable law I and a man above the content of the content

Instrument is acceptable to Lender.

To the extent permitted by applicable law, Lender may charge a reasonable fee as a condition to Lender's consent to the loan assumption. Lender may also require the transferse to sign an assumption agreement that is acceptable to bender and that obligates the transferse to keep all the promises and agreements made in the Note and in this Fairr ty Instrument. Borrower will continue to be obligated under the Note and this Security Instrument unless Lender releases Borrower in writing.

If Lender exercises the option to require immediate payment in full, Lender shall give Borrower notice of acceleration. The actice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which Forrower must pay all sums secured by this Security Instrument. If Borrower falls to pay these sums prior to the expiration of this period, Lender may invoke any remedica permitted by this Security Instrument without Lander notice or demand on Borrower.
