FLEXEQUITY ACCOUNT MORTGAGE

THIS FLEXEQUITY MORTGAGE is made this 12th day of April 1997 by and between John J. Gillan and Mary Sue Gillan, Husband and Wife

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated April 12, 1997 (herein "Note") with a credit limit of One Hundred Thousand Dollars and no/100 dollars (\$ 100,000.00) (a minimum amount of \$10,000.00) of which an initial advance of XXXXXXXXXXXXXXXXXXXXXXXXXX/XXX (\$ XXX) has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest would be payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may accrue prior to Lender's receipt of the property if any, plus one-twelfth of yearly premium installments for hazard insurance.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. 3. **PRIOR ENCUMBRANCE; CHARGES; LIENS.** Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due. 
