5. Hazard Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage", and such other hazards as Lender may

6. Preservation and Maintenance of Property; Leaseholds; Compositioniums; Planned Unit Developments. 7. Protection of Lender's Security. 9. Condemnation. 10. Borrower Not Released; Forbearance By Lender Not a Waiver. - 11. Successors and Assigns Bound; Joint and Several Liability; Co-signers.
