#### THE MORTGAGOR COVENANTS:

An Additional Advance Agreement may be given and accepted for such advance and provision may be made for different monthly payments and a different interest rate and other express modifications of the contract, but in all other respects this contract shall remain in full force and effect us to said indebtedness, including all advances.

- If That the Mortgagee may employ counsel for advice or che, legal service at the Mortgagee's discretion in connection with any dispute as to the debt hereby secured or the lien of this Instrument or any litigation to which the Mortgagee may be made a party on account of this lien or which may affect the title to the property securing the indebtedness hereby secured or which may affect said debt or lien and any reasonable altorney's fees so incurred shall be adder to and be a part of the debt hereby secured.
