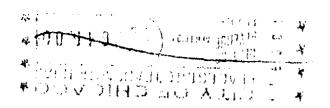

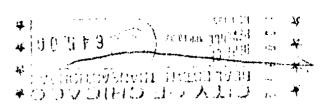
LEGAL DESCRIPTION
