This matter coming on to be heard on the regular trial call and on motion of plaintiff, City of Chicago, and this court having jurisdiction over the parties and being fully advised in the premises, the court orders:

1. The judgment(s) hereby entered on the date(s) of 1/14/96, 12/2/96 in the total amount(s) of \$ 74,500 plus \$80.00 in court costs against defendant(s) Frank Freeman and Carvin Freeman shall stand as final judgment and that leave for enforcement on said judgment(s) is hereby granted plaintiff, City of Chicago, instanter.

2. Defendant(s) Frank Freeman and Carvin Freeman his/her/their agents, heirs, successors or assigns, be and are permanently enjoined and restrained from renting, leasing, using or occupying the subject premises until full compliance with City of Chicago codes as stated in this case and further order of court. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

3. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.
