AN ORDINANCE APPROVING MODIFICATIONS TO THE PREVIOUSLY APPROVED SITE PLAN FOR THE MIXED USE COMMERCIAL/RESIDENTIAL DEVELOPMENT AT 5000 OAKTON STREET AND 5001 WARREN AVENUE, SKOKIE, ILLINOIS IN THE B-COOWNTOWN DISTRICT AND TO AMEND VILLAGE ORDINANCE NUMBER 96-4-Z-2582 ACCORDINGLY

WHEREAS, on April 11, 1196 the Mayor and Board of Trustees of the Village of Skokie adopted Village Ordinance Number 96-4-Z-2582 granting site plan approval and relief form the Zoning Ordinance to permit the construction and establishment of a mixed use commercial/residential development at the property legally described as follows:

PARCEL 1: LOTS 18 THROUGH 23 AND THE EASTERLY 10 FEET OF LOT 24 IN BLOCK 1 IN THE SUBDIVISION OF LOT 2 IN PETER BLAMEUSER'S SUBDIVISION OF THE SOUT 1 105 ACRES OF THE SOUTH EAST 1/4 OF SECTION 21, TOWNSHIP 41 MORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, III COOK COUNTY, ILLINOIS.

WHEKEAS, the owner of the property legally described above requested that they be permitted to mostify the previously approved Site Plan to atlow the reduction of the number of residential units in the building with the common address of 5001 Warren Street, elimination of the driveryay from Niles Avenue, relocation of the overhead garage door from the east elevation to the east and west elevations and to eliminate a window at the southeast corner of the 5000 Oakton Street building; and

WHEREAS, pursuant to Section 13.4.1 of the Skokie Zoning Ordinance, the Plan Commission Chairman, Corporation Counsel and Director of Planning reviewed the request and found that the requested modification is in substantial compliance with the Site Plan Approval granted on April 15, 1997; and

WHEREAS, if was recommended to the Mayor and Bours of Trustees that the requested modification be granted; and

WHEREAS, the Mayor and Board of Trustees concurred in the aforesaid recommendations and findings of the Plan Commission Chairman, the Commission Counsel, and Director of Planning;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Skokie, Cook County, Iffinois:

<u>Section 1</u>: That the owner of the subject property is hereby granted the request to modify the previously approved Site Plan for the existing mixed use commercial/residential development at 5000 Oakton Street and 5001 Warren Avenue.

That condition number 3 be amended to refer to: 3. a. revised first floor (garage) plan dated October 22, 1996; b. typical floor plan dated January 2, 1997; c. revised partial (south) east elevation dated January 2, 1997; d. revised partial (north) elevation dated October 22, 1996; en revised partial (north) west elevation Clated October 22, 1996. That an other conditions of Village Ordinance Number 98-4-Z-2582 Section 2: shall remain in full force and effect Section 3: That a notice of the enactment of this Ordinance incorporating the conditions contained herein be approved by the owner of the property in writing and duly recorded in the office of the Recorder of Derids for Cook County at the owner's expense. Section 4: That this Ordinance shall win full force and effect from and after its passage, approval and recordation as provided by law. ADOPTED this 23 day of April, 1997.
