## ADDENDUM

P I N 20-06-400-024

The part of Block 3 (vacated) in Stone and Whitney's Subdivision of parts of Section 6 and 7, Township 38 North, Range 14, East of the Third Principal Meridian, bounded and described as follows Beginning on the East line of said Block 3 at a point which is 331.00 feet South from the Northeast corner of said Block 3, and running thence South along said East line of Block 3, a distance of 265.70 feet to the Southeast corner of Block 3, thence West along South line of said Block 3, a distance of 579.77 feet to the Southwest corner of Block 3; thence North along the West line of said Block 3, a distance of 223.00 feet, thence Northeasterly along a straight line, (the Northeasterly terminus of which is a point 183.00 feet East of the West line and 250.0 feet South of the North line of said Block 3) a distance of 76.24 feet to the point of intersection of said straight line with a line which is 331 feet South from and parallel with the North line of Said Block 3, and thence East along said last described parallel line, a distance of 516.50 feet to the point of beginning, in Cook County, Illinois.
