#### LEGAL DESCRIPTION

#### PARCEL ONE (LEASED PREMISES)

COMMENCING AT THE INTERSECTION OF A LINE 50.00 FEET EAST OF THE MEST LINE OF TRE NORTHWEST 1/4 CF SECTION 24, TOWNSRIP 36 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, AND A LINE 50.00 FEET SOUTH OF THE NORTH LINE OF THE NORTHWEST 1/4 OF SAID SECTION 24, SAID POINT OF COMMENCING ALSO BEING THE INTERSECTION OF THE SOUTH LINE OF 159TH STREET AND THE EAST LINE OF KEDEIE AVENUE, AND ALSO THE NORTHWEST CORNER OF SAID OUTLOT "A"; THENCE SOUTH 0°-22'-33" WEST ALONG THE EAST LINE OF KEDEIE AVENUE, SAID LINE ALSO DEING THE WEST LINE OF SAID OUTLOT "A" A DISTANCE OF 12.00 FEET AS MEASURED AT RIGHT ANGLES TO THE NORTH LINE OF OUTLOT "A", ALSO DEING THE SOUTH LINE OF 159TH STREET TO THE POINT OF BEGINNING; THENCE NORTH 90" EAST ALONG A LINE BRING 12.00 FEET SOUTH "A", ALSO BEING THE SOUTH LINE OF 159TH STREET A DISTANCE OF 244.00 FEET; THENCE SOUTH O"-12'-33" WEST A DISTANCE OF 123.50 FEET; THENCE NORTH 0'-12'-33" WEST A DISTANCE OF 123.50 OUTLOT "A", ALSO BEING THE SOUTH LINE OF REDSIE AVENUE; THENCE NORTH 0'-12'-33" EAST ALONG THE WEST LINE OF REDSIE AVENUE; THENCE NORTH O'-12'-33" EAST ALONG THE WEST LINE OF REDSIE AVENUE; THENCE NORTH O'-12'-33" EAST ALONG THE WEST LINE OF SAID OUTLOT "A", ALSO BEING THE EAST LINE OF REDSIE AVENUE A DISTANCE OF 123.50 FEET TO THE POINT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS.

#### PARCEL TWO (SHOPPING CENTER ELSENENTS)

THE ABOVE-DESCRIBED LEASED PREMISES IS A PART OF THE CANTERSURY SHOPPING CENTER (THE "SHOPPING CENTER") WHICH IS MORE PARTICULARLY DESCRIBED ON PAGE 2 OF THIS EXHIBIT A." THE LEASE GRANTS THE FOLLOWING NON-EXCLUSIVE EASEMENTS WHICH AND APPURTENANT TO THE LEASED PREMISES, WHICH APPECT THE SHOPPING CENTER AND WHICH ARE COTERNINOUS-WITH THE LEASE AND ANY EXTENSIONS THEPOO:

- (a) THE RIGHT AND EASEMENT TO TIE INTO AND USE EXISTING UTILITIES.
