TOGETHER with all the improvements now or hereafter erected on the property, and all easements, rights, appenditances and rests all of which shall be deemed to be and remain a part of the property applicably this Mortgage; and all of the foregoing, together with said property (or the leasehold extent if this Mortgage is on a leasehold) are hereinafter referred to as the "Property."

Borrower coverants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, and that the Property is unencumbered, except for encumbrances of record. Borrower coverants that Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to encumbrances of record.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- I. Payment of Principal and Interest. Borrower shall promptly pay when due the principal and interest indebtedness evidenced by the Note and late charges as provided in the Note.
- 2. Punds for Taxes and Insurance. - 3. Application of Payments. Unless applicable law provides otherwise, all payments received by Lender under the Note and paragraphs 1 and 2 hereof shall be applied by Lender first in payment of amounts payable to Lender by Norrower under paragraph 2 hereof, then to interest payable on the Note, and then to the principal of the Note.
- 4. Prior Mortgages and Deeds of Trust; Charges; Liens. Borrower shall perform all of Borrower's obligation's reder any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage, including Borrower's covenants to make payments when due. Borrower shall pay or cause to be paid all taxes, assessments and other charges, lives and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground resits, if any.
