The sale will be held at 47 West Polk Street, Atrium Level, Chicago, Illinois on June 23, 19.97, at 9.30 a m. local time. The Secretary of Housing and Urban Development will bid. \$.84,024.60

There will be no proration of taxes, ren's or other income or liabilities, except that the purchaser will pay, at or before closing, his provide share of any real estate taxes that have been paid on the project by the Secretary to the date of the foreclosure sale.

When making their hid, all bidders except the Secretary must submit a deposit totaling \$8,402.46 [10% of the Secretary's hid] in the form of a certified check or cashier's check made out to the Secretary of HUD. Each oral hid need not be accompanied by a deposit. If the successful hid is oral, a deposit of \$8,402.46 must be presented before the hidding is closed. The deposit is nonrefundable. The remainder of the purchase price must be definered within 24 hours of the sale or at such other time as the Secretary may determine for good cause shown, time being of the essence. This amount, like the hid deposits, must be delivered in the form of a certified or cashier's check. If the Secretary is the high bidder, he need not pay the hid amount in each. The successful hidder will pay all conveyancing fees, all real estate and other taxes that are disc on or after the date of closing and all other costs associated with the transfer of title. At the concusion of the sale, the deposits of the unsuccessful hidders will be returned to them

The Secretary may grant an extension of time within which to deliver the remainder of the payment. All extensions will be for 15-day increments for a fee of \$150.00, paid in advance. The extension fee shall be paid in the form of a certified or cashier's check made payable to the Secretary of Housing and Urban Development. If the high bidder closes the sale prior to the expiration of any extension period, the unused portion of the extension fee shall be applied toward the amount due.

If the high bidder is unable to close the sale within the required period, or within any extensions of time granted by the Secretary, the high bidder hay be required to forfeit the cash deposit or, at the election of the foreclosure commissioner after consultation with the HUD Field Office Representative, will be liable to HUD for any costs incurred as a result of such failure. The Commissioner may, at the direction of the HUD Field Office Representative, offer the Property to the second highest bidder for an amount equal to the highest price offered by that bidder.

There is no right of redemption, or right of possession based upon a right of redemption, in the mortgagor or others subsequent to a foreclosure completed pursuant to the Act. Therefore, the Foreclosure Commissioner will issue a Deed to the purchaser(s) upon receipt of the entire purchase place in accordance with the terms of the sale as provided herein. HUD does not guarantee that the property will be vacant.

The amount that must be paid if the Mortgage is to be reinstated prior to the schedule sale is \$ 16,382.50 as of June 1, 1997, plus all other amounts that would be due under the mortgage agreement if payments under the mortgage had not been accelerated, advertising costs and postage expenses incurred in triving notice, mileage by the most reasonable road distance for posting notices and for the Foreclosure Commissioner's attendance at the sale, reasonable and customary costs incurred for title and lien record searches, the necessary out-of-pocket costs incurred by the Foreclosure Commissioner for recording documents, a commission for the Foreclosure Commissioner, and all other costs incurred in connection with the foreclosure prior to reinstatement
