- 9. ENTITY WARRANTIES AND REPRESENTATIONS. If Mortgagor is an entity other than a natural person (such as a corporation or other organization). Mortgagor makes to Lender the following warranties and representations which shall continue as long as the Secured Debt remains outstanding:

premiums, "loss of rents" insurance, guest receipts, revenues, royalties, proceeds, bonuses, accounts, contract rights, general intangibles, and all rights and claims which Mortgagor may have that in any way pertain to or are on account of the use or occupancy of the whole or any part of the Property.

In the event any item listed as Leases or Rents is determined to be personal property, this Security Instrument will also be regarded as a security agreement.

Mortgagor will promptly provide Lender with true and correct copies of all existing and future Leases. Mortgagor may collect, receive, enjoy and use the Rents so long as Mortgagor is not in default. Except for one lease period's rent, Mortgagor will not collect in advance any future Rents without Lender's prior written consent. Upon default, Mortgagor will receive Rents in trust for Lender and Mortgagor will not commingle the Rents with any other funds. - D. Except as previously disclosed and acknowledged in writing to Lender. Mortgagor and every tenant have been, are and shall remain in full compliance with any applicable Environmental Law and Mortgagor has no knowledge of or reason to believe there is any pending or threatened investigation, claim, or proceeding of any kind relating to (1) any Hazardous Substance located on, under or about the Property; or (2) any violation by Mortgagor or any tenant of any Environmental Law. #### ADDENDUM TO DEED OF TRUST/MORTGAGE

(this "Addendum")

This Addendum amends and supplements the Deed of Trust or Mortgage ("Mortgage") to which it is attached, such Mortgage being incorporated herein by reference for all purposes and vice versa.

- 1. That certain Credit Agreement-Revolving (the "Master Agreement"), entered into for and between First State Bank, Austin ("Mortgagee") and Schlotzsky's, Inc. ("Mortgagor") is incorporated herein by reference for all purposes.
- 2. All representations and warranties set forth in the Mortgage are replaced and superseded in their entirety by the representations and warranties set forth in the Master Agreement.
- 3. Provided that Mortgagor is in compliance with all of the provisions of the Master Agreement and that no default or event of default exists thereunder (or if any exists, that the same has been waived in writing by Mortgagee):
  - a. Mortgagee shall not, notwithstanding any "due on sale" or similar clause or provision contained in the Montgage, declare the indebtedness governed by the Master Agreement due and payable by virtue of the sale, transfer, or encumbrance of or the granting of a lien upon all or any portion of the property made the subject of the Mortgage (the "Property") and
  - b. Mortgagee will, upon request by Mortgagor, release all or a portion of its lien upon and interest in the Property without any payment due from Mortgagor and will record such release in the real property records where the Property is located.
- 4. Upon request from any franchisee of Mortgagor which is leasing all or portion of the Property from Mortgagor, Mortgagee will execute and deliver (subject to the simultaneous execution and delivery by such franchisee) an agreement in substantially the form of Exhibit "A" to the Master Agreement providing for the Mortgagee to grant non-disturbance to the franchisee and for the franchisee to provide an estoppel and an agreement to attorn to the Mortgagee and to subordinate any interest it may have in the Property to the interest of Mortgagee.
- 5. Notwithstanding any covenants or undertakings by Mortgagor under the terms of the Mortgage to the contrary:

- a. All covenants in the Mortgage relating to insurance of the Property are superseded in their entirety and replaced by the covenants with respect thereto set forth in the Master Agreement;
- b. All covenants in the Mortgage relating to the right of the Mortgagor to cure any monetary or non-monetary default are superseded in their entirety and are replaced by the covenants with respect thereto set forth in the Master Agreement (except, to the extent required by the local laws of the jurisdiction in which the Property is situated, the covenants of the Mortgage shall govern if the foregoing provisions and the covenants provided for in the Master Agreement would not be permitted by such local laws or would not be enforceable thereunder;
- c. All covenants in the Mortgage relating to the rights of Mortgagee to accelerate indebtedness secured by the Property on account of Mortgagee's deeming itself insecure are superseded and replaced in their entirety by the provisions with respect thereto set forth in the Master Agreement (except, to the extent required by the local laws of the jurisdiction in which the Property is situated, the covenants of the Mortgage shall govern if the foregoing provisions and the covenants provided for in the Master Agreement would not be enforceable thereunder).
- 6. To the extent that the terms and conditions of this Addendum are in conflict with the terms and conditions of the Mortgage, this Addendum shall be controlling in all respects. In all other respects, the terms and conditions of the Mortgage are ratified and confirmed.
