LOAN MODIFICATION AGREEMENT

This instrument is a loan Modification Agreement ("Modification") by and between The FrivateBank and Trust Company, an Illinois banking corporation ("Lender"), Capcor Equities, an Illinois partnership ("Borrower"), and Michael L. Caprile, Renate Rankin, now known as Renate Caprile, Sandra K. Burns, Roman S. Borowych, Robert A. Reaumond, Julie A. Reaumond Hilda I. Paladino, Opal Weel, Sam Interrante, Richard A. Carlson, Disanne Carlson, Scott Putman, Gale Vance, David Madsen, Herb Peterson, Georgene Peterson, Robert Heiberger, Louis Caprile, Frances Caprile, and Michelle Dremmer (collectively "Guarantors").

RECITALS:

- A. Borrower holds fee simple title to certain real estate commonly known as 822-36 South Austin, Oak Park, Illinois, which is legally described on Exhibit A attached hereto ("Real Estate").
- B. On April 6, 1993, Borrower executed and delivered to Lender a Promissory Note in the amount of \$1,300,000 ("Note") which

evidences a loan in the amount of \$1,300,000 ("Loan"). To secure the Note, Borrowers and Guarantors executed and delivered to Lender the following documents ("Security Documents"):

- Security Agreement ("Mortgage") executed by Borrower covering the Real Estate and that real estate commonly known as 618-32 South Austin, Oak Park, Illinois, which is legally described on Exhibit B attached hereto ("Released Property"), which Mortgage was recorded with the Recorder of Deeds on May 8, 1993 as Document No. 93261094;
- 2. An Environmental Indemnity Agreement executed by Borrower and Guarantors:
- 3. UCC-2 and UCC-2 financing statements in connection with the Mortgage executed by Borrower, which were filed and recorded; and
- 4. A Guaranty of Note, Mcrcgage and other undertaking (*Guaranty*) executed by Guarantors.
- C. On August 2, 1996 Borrower paid \$632,000 to Lender, and on September 11, 1996, Lender executed a release deed ("Release") releasing the Released Property, which Release was recorded with the Recorder of Deeds on _______ as Document No.

D. In connection with the Release, Borrower has requested Lender to reduce the monthly payment amount due under the Loan. Lender is agreeable to this request subject to the covenants, conditions and restrictions contained herein.

- NOW, THEREFORE, in consideration of good and valuable consideration, the parties agree as follows:
- 1. Subparagraph (c) of the Note is hereby modified and amended to delete it in its entirety and substitute in its place the following paragraph:
 - (c) On June 1, 1996 and on the first day of each succeeding month thereafter to and including September 1, 1996, there shall be paid on account of the principal and interest of this Note a payment in the amount of \$9,739.64, which such payment shall be applied first to interest at the rate of eight and one-fourth (8.25%) percent, and the remainder to principal. On September 1, 1996 and on the first day of each succeeding month thereafter until the Maturity Date, there shall be paid on account of fine principal and interest of this Note a payment in the amount of Four Thousand Nine Hundred Forty-five Dollars and Eighty-four Cents (\$4,945.84), which payment shall be applied first to interest at the rate of eight and one fourth percent (8.25%) and the remainder to principal
- 2. This Modification shall be effective upon Lender's receipt of this Modification executed by the parties hereto and a title insurance endorsement which extends the effective date of the Loan Title Insurance Policy until the recording date of this Modification and insures the Mortgage as modified by this Modification.
- 3. This Modification shall constitute an amendment of the Note and Security Documents and wherever in said instruments or in any other instrument evidencing or securing the indebtedness evidenced by the Note ("Loan Documents") reference is made to the Loan Documents aforesaid, such reference shall be deemed a reference to such Loan Documents as hereby modified and amended. All other provisions of the Loan Documents remain unchanged.

Nothing herein contained shall in any manner affect the lien or priority of the Security Documents, or the covenants, conditions and agreements therein contained or contained in the Note and Loan Agreement.

- 4. In the event of conflict between any of the provisions of the Loan Documents and this instrument, the provisions of this instrument shall override and control.
- Guarantors hereby reaffirm their obligations under the Guaranty and agree that the Guaranty is amended and extended to cover and guarantee the Note as modified by this Modification, notwithstanding the Release. All references in the Guaranty to the Note shall mean the Note as modified hereby. Guarantors hereby expressly acknowledge and confirm that by executing this Modification and the Release, Lender has not waived, altered or modified Lender's rights under any of the Loan Documents to amend, extend, renew or modify or otherwise deal with the obligations of the parties hereto or any of the security given to Lender in connection therewith without the consent of Guarantors and without such action releasing, modifying, or affecting the obligations of Guarantors or affecting the security heretofore granted to lender.
- Borrower and Guarantors hereby renew, remake and affirm the representations and warranties contained in the Loan Documents.
- 7. Borrower and Guarantors hereby agree to pay all of Lender's expenses arising out of and in connection with this Modification including, but not limited to, title insurance premiums, recording fees and attorneys' fees performed in the

preparation of necessary documentation.
