4. Prior Mortgages and Deeds of Trust; Charges; Liens. 5. Hazard Insurance. - 15. Rehabilitation Loan Agreement. Borrower shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, repair, or other loan agreement which Borrower enters into with Lender. Except as provided in paragraph 16 hereof, upon Borrower's breach of any covenant or agreement of Borrower is this Mortgage, Including the covenants to pay when due any sums secured by this Mortgage, Lender prior to accelerate shall give notice to Borrower as provided in paragraph 12 hereof specifying; (1) the breach; (2) the action required to care such breach proceed and (3) in date, not less than 10 days from the date the notice is mailed to Borrower, by which such breach most be cured; and (4) that failure to care such breach on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding, and sale of the Property. The notice shall further before Borrower of the right to relustate after acceleration and the right to assert in the foreclosure proceeding the nonexistence of a default or any other defense of Borrower to acceleration and furnelosure. If the breach is not cured on or before the late specified in the notice, Lender, at Lender's aption, may declare all of the sums secured by this Mortgage to be immediately due and payable without further demand and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable actors syst fees and costs of documentary evidence, abstracts and after reports.
- Borrower's Right to Relatate. Notwithstanding Lender's expleration of the sums secured by this Mortgage due to Borrower's breach. Borrower shall have the right to have any procedure, begun by Lender to enforce this Mortgage discontinued at any time prior to entry of a judgment enforcing this Mortgage if: (a) Borrower pays Lender all sums which would be then due under this Mortgage and the Note had no acceleration occurred, (b) Borrower cures all breaches of any other covenants or agreements of Borrower contained in this Mortgage; (c) Borrower pays (i) reasonable expenses incurred by Lender in enforcing the covenants and agreements of Borrower contained in this Mortgage, and in enforcing Lender's remedies as provided in paragraph 17 hereof, including, but not limited to, reasonable attorneys' fees; and (a) Porrower takes such action as Lender may reasonably require to assure that the lien of this Mortgage, Lender's interest is the Property and Borrower's obligation to pay the sums secured by this Mortgage shall continue unimpaired.  - 21. Walver of Homestead. Borrower hereby waives all right of homestead exemption in the Property.
