

GENERAL POWER OF ATTORNEY

(c) To establish, make withdrawals from, issue drafts or checks on or make deposits to any bank account or savings or loan account or other cash account, in my name or in the name of my attorney, for such purposes as my attorney deems appropriate;

such other documents and instruments in writing of whatsoever kind and nature as my attorney deems appropriate; and

Without limiting the generality of the foregoing:

(1) My attorney shall at any time and for any reason have the power to appoint, either as a substitute for him, or to perform some or all powers conferred on him, a substitute attorney, who shall have such powers as shall be conferred upon him by my attorney herein named, and my attorney shall further have the power to remove such substitute as such substitute attorney at any time and for any reason whenever she deem it desirable.

(2) The specification of any powers under any of the paragraphs (a) through (e), inclusive, above shall not be deemed or held to constitute any limitation or restriction on the generality of any other powers granted to or conferred on my attorney hereunder.

Any person, firm or corporation to whom a copy of this power of attorney, or any excerpt hereof has been delivered, accompanied by a certificate from my attorneys designated hereunder that (1) it is a true and correct copy or excerpt, as the case may be, and (2) this power is still in force and effect, unrevoked, may rely wholly on such copy or excerpt and certification, as if the original signed copy hereof were delivered to such person, firm or corporation.
