

17. INSURANCE. Mortgagor shall keep Property insured against loss by fire, flood, theft and other hazards and reasonably associated with the Property due to its type and location. This insurance shall be maintained in the amounts and for the periods that Lender requires. If any section of this Security Instrument cannot be enforced according to its terms, that section will be severed and will not affect the enforceability of the remainder of this Security Instrument. Whenever used, the singular shall include the plural and the plural the singular. The captions and headings of the sections of this Security Instrument are for convenience only and are not to be used to interpret or define the terms of this Security Instrument. Time is of the essence in this Security Instrument.


