- 1. ASSIGNMENT. In consideration of the loan evidenced by the promissing note or credit agreement described above (the "Note"), Grantor absolutely assigns to Lender all of Grantor's interest of the leases and tenancy agreements (the "Leases") now or hereafter executed which relate to the real property described in Schedule A which is attached to this Agreement and incorporated herein by this reference and any improvements located thereon (the "Premises") including, but not limited to, the leases described on Schedule B attached hereto and incorporated herein by reference. - 2. MODIFICATION OF LEASES. Grantor grants to Lender the power and authority to modify the terms of any of the Leases and to surrender or terminate the Leases upon such terms as Lender may determine.
 - 3. COVENANTS OF GRANTOR. Grantor covenants and agrees that Grantor wit:

a. Observe and perform all the obligations imposed upon the landlord under the Leases.

 Refrain from discounting any future rents or executing any future assignment of the Leases or collect any rents in advance without the written consent of Lender.

c. Perform all necessary steps to maintain the security of the Leases for the benefit of Lender including, if requested, if the periodic submission to Lender of reports and accounting information relating to the receipt of rental payments.

d. Refrain from modifying or terminating any of the Leases without the written consent of Lender.

- Execute and deliver, at the request of Lender, any assurances and assignments with respect to the Leases as Lender may periodically require.
- 4. REPRESENTATIONS OF GRANTOR. Grantor represents and warrants to Lender that:
 - The tenants under the Leases are current in all rent payments and are not in default under the terms of any of the Leases.
- Each of the Leases is valid and enforceable according to its terms, and there are no claims or defenses presently existing which could be asserted by any tenant under the Leases against Grantor or any assignee of Grantor.

c. No rents or security deposits under any of the Leases have previously been assigned by Grantor to any party other than Lender.

Grantor has not performed any act or executed any instrument which might prevent Lander from collecting rents. and taking any other action under this Assignment.

- 5. GRANTOR MAY RECEIVE RENTS. As long as there is no default under the Note described above, the Mortgage ecuring the Niote, this Agreement or any other present or future obligation of Borrower or Grantor to Lander ("Obligations"), Grantor may collect all rents and profits from the Leases when due and may use such proceeds in Grantor's business operations. However, Lender may at any time require Grantor to deposit all rents and profits into an account maintained by Grantor or Lender at Lender's institution.
- DEFAULT AND REMEDIES. Upon default in the payment of, or in the performance of, any of the Obligations. Lender may at its option take possession of the real property and the improvements and have, hold, manage, lease and operate the Premises on terms and for a period of time that Lander deems proper. Lender may proceed to collect and receive all rents, income and profits from the Premises, and Lander shall have full power to periodically make alterations. renovations, regalrs or replacements to the Premises as Lender may deem proper. Lender may apply all rents, income and profits to the payment of the cost of such alterations, renovations, repairs and replacements and any expenses incident to taking and retaining possession of the real property and the management and operation of the real property. Lender may keep the Framises properly insured and may discharge any taxes, charges, claims, assessments and other liens which may accure. The expense and cost of these actions may be paid from the rents, issues, income and profits. received, and any unperformounts shall be secured by the Note and Mortgage. These amounts, together with attorneys' fees, legal expenses, and other costs, shall become part of the indebtedness secured by the Mortgage and for which this Assignment is given.
- 7. POWER OF ATTORNEY. Grantor irrevocably authorizes Lander as Grantor's attorney-in-fact coupled with an Interest, at Lender's option, upon taking possession of the real property and improvements under this Assignment, to lease or re-lease the Premises or any part thereof, to cancel and modify Leases, evict tenants, bring or defend any suits in connection with the possession of the Premises in the name of either party, make repairs as Lander deems appropriate and perform such other acts in connection with the management and operation of the real property and improvements as Lender may deum proper. The receipt by Lender of any rents, income or profits under this Assignment after institution of foreclosure proceedings under the Mortgage shot cure any default or affect such proceedings or sale which may be held as a result of such proceedings.
- a. BEHEFICIAL NITEREST. Lender shall not be clarated to perform or discharge any obligation, duty or fability under the Leases by reason of this Assignment. Grantor hereby agrees to indemnify Lender and to hold Lender harmless from any and all fiability, loss or damage which Lender may incur under the Leases by reason of this Assignment and from any and all claims and demands whatsoever which may be asserted against Lender by reason of any alleged obligations or undertakings on Lander's part to perform or disclaims any of the terms or agreements contained in the Leases. Should Lender Incur any liability, loss or damage under the Lagues or under or by reason of this Assignment, or in the defense of any such claims or demands, the amount of such loss, Michaeling costs, legal expenses, and reasonable attorneys' fees shall be secured by the Mortgage and for which this Assig ment was given. Grantor agrees to reimburse Lender immediately upon demand for any such costs, and upon failure of Grantor to do so, Lender may accelerate and declare due all sums owed to Lender under any of the Obligations.

Grantor hereby releases the tenants from any flability for any rents paid to Lendin or any action taken by the tenants at the direction of Lender after such written notice has been given.
- 19. INDEPENDENT RIGHTS. This Assignment and the powers and rights granted are separated independent from any obligation contained in the Mortgage and may be enforced without regard to whether Landay enginees foreclosure proceedings under the Mortgage. This Assignment is in addition to the Mortgage shall not affect, Granish or impair the Mortgage. However, the rights and authority granted in this Assignment may be exercised in conjunction with the
- MODIFICATION AND WAIVER. The modification or waiver of any of Granton's obligations or Lenden's rights under this Agreement must be contained in a writing signed by Lender. Lander may perform any of Granton's obligations or delay or fall to exercise any of its rights without causing a waiver of those obligations or rights. A waiver on one occasion shall not constitute a walver on any other occasion.  - 13. NOTICES. Any notice or other communication to be provided under this Agreement shall be in writing and sent to the parties at the addresses indicated in this Agreement or such other address as the parties may designate in writing from time to time.

14. SEVERABILITY. If any provision of this Agreement violates the law or is unenforceable, the rest of the Agreement shall remain valid.

15. COLLECTION COSTS. If Lender hires an attorney to assist in collecting any amount due or enforcing any right or ramedy under this Agreement, Grantor agrees to pay Lander's attorneys' fees, legal expenses and collection costs.

18. MISCELLANEOUS.

a. A default by Grantor under the terms of any of the Lease which would entitle the tenant thereunder to cancel or terminate such Lease shall be deemed a default under this Assignment and under the Note and Mortgage so long as, in Lender's opinion, such default results in the impairment of Lender's security.

b. A violation by Grantor of any of the covenants, representations or provisions contained in this Assignment shall

be deemed a default under the terms of the Note and Mortgage.

c. This Agreement shall be binding upon and inure to the benefit of Grantor and Lender and their respective successors, assigns, trustees, receivers, administrators, personal representatives, legalees, and devisees.

d. This Agreement shall be governed by the laws of the state indicated in the address of the real property. Grantor consents to the jurisdiction and venue of any court located in the state indicated in the address of the real property in the event of any legal proceeding under this Agreement.

e. This Agreement is executed for business _purposes. All references to Grantor in this Agreement shad include all persons signing below. If there is more than one Grantor, their obligations shall be joint and several. This Agreement and any related documents represent the complete and integrated Cook County understanding between Grantor and Lender pertaining to the terms and conditions of those documents.
