### THIRD MODIFICATION AND EXTENSION AGREEMENT

SYSTIMY

- 1) That the current principal balance of the loan is \$60,000.00.
- 2) That the Maturity Date of such Note and Mortgage is hereby extended from April 1, 1998 to October 1, 1998.
- 3) That the Note is hereby modified to provide that if a payment is made one or more days after its due date, Borrower will be charged Four (4.0%) percent per annum in excess of the then applicable interest rate. Accrued daily, on the outstanding principal balance until such payment is made.
- 4) In all other respects, the Note hereinbefore described shall remain unchanged and in full force and effect.
