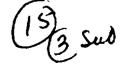

THIS JUNIOR REVOLVING MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS to made this 27th day of April, 1998 by AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED SEPTEMBER 1, 1997 AND KNOWN AS TRUST NO. 123322-01, AMERICAN MATIONAL BANK AND TRUST COMPANY OF CHICAGO, SUCCESSOR TRUSTEE TO FIRST CHICAGO TRUST COMPANY OF ILLINOIS, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED NOVEMBER 1, 1991 AND KNOWN AS TRUST NO. OP-011503, AMERICAN NATIONAL BANK IN AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED SEPTEMBER 1, 19/7 AND KNOWN AS TRUST NO. 123324-09, AND AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE - UNDER TRUST AGREEMENT DATED DECEMPER 1, 1986 AND KNOWN AS TRUST NO. 100971-03, (collectively, the "Mortgagor"), and JOHN R. KKENGER AS TRUSTEE OF THE JOHN R. KRENGER LIVING TRUST UNDER TRUST AGREEMENT DATED JANUARY 20, 1994 (the "Beneficiary"), to THE FIRST NATIONAL BANK OF CHICAGO, (the "Mortgates"), a national banking association, organized and existing under the laws of the United States of America, having its principal office at One First National Plaza, N Chicago, Illinois 60670.

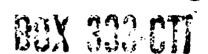
WITNESSETH:

WHEREAS, the Mortgagor, the Beneficiary, and John R. Krenger are indebted to Mortgagee in the principal sum of TWO MILLION and no/100 Dollars (\$2,000,000.00) or so much thereof as may be outstanding from time to time under a Revolving Business Loan Note of even date payable to the order of Mortgagee in the principal amount of \$2,000,000.00 (said note and all modifications, renewals or extensions thereof, the "Note") plus interest in the amount as provided in and evidenced by the Note, which Note is incorporated herein by this reference. The Note has an adjustable rate and revolving feature.

NOW, THEREFORE, to secure (a) the payment of the indebtedness evidenced by the Note together with interest thereon (the "Indebtedness") and any fees in connection therewith, (b) the repayment of the advances or expenses of any kind incurred by Mortgagee pursuant to the provisions of or on account of the Note or this Mortgage, (c) the repayment of future advances, if any, disbursed by Mortgagee in accordance with the terms of the Mortgage or the Note in excess of the principal of the Indebtedness, and (d) the performance and observance of all of the terms, covenants, provisions and agreements of this Mortgage, the Note and all other documents now or hereafter executed in connection with the Indebtedness (collectively, the "Loan Documents"), all of the foregoing not to exceed 300% of the principal amount of the Note, the Mortgagor and Beneficiary agree as follows:

ARTICLE I

1



1.01 The Mortgagor hereby grants, bargains, sells, releases, conveys, assigns, transfers, mortgages and confirms unto the Mortgagee, and grants a security interest in, the real estate described in Exhibit A attached hereto and made a part hereof (the "Real Estate"), which with the property, estates and interests hereinafter described is referred to herein as the "Property";

Together with, all rents, issues, profits, royalties, income and other benefits derived from the Real Estate subject to the right, power and authority hereinafter given to Mortgagor to collect and apply such rents;

Together with, all leasehold estate, right, title and interest of Mortgagor in and to all leases or subleases covering the Real Estate or any portion thereof now or hereafter existing or entered into, and all right, title and interest of Mortgagor thereunder, including, without limitation, all cash or security deposits, advance rentals, and deposits or payments of similar nature;

Together with, all easements, rights-of-way and rights pertaining thereto or as a means of access thereto, and all toperarms, hereditaments and appurtenances thereof and thereto;

Together with, any and all buildings and improvements now or hereafter erected thereon, including, but not limited to, the fixture:, attachments, appliances, equipment, machinery, and other articles attached to said buildings and improvements; 700

Together with, all the care interest, right, title, other claim or demand, including claims or demands with respect to the proceeds of insurance which Mortgagor now has or may hereinafter acquire in the Real Estate, and any and all awards made for the taking of eminent domain, or by any proceeding or purchase in lieu thereof, of the whole or any part of the Real Estate, is cluding without limitation any awards resulting from a change of grade of streets and awards for severance damages.

To have and hold the Property unto the Mongace, and its successors and assigns forever, for the uses and purposes herein set forth.

ARTICLE II REPRESENTATIONS

- 2.01 Mortgagor represents it has good and marketable title to the Property. Mortgagor represents that it has good right and full power to sell and convey the same and that it his duly executed and delivered this Mortgage pursuant to proper directions and that Mortgagor will make my nurther assurances of title that the Mortgagee may require and will defend the Property against all claims and decay its whatsoever.
- 2.02 Mortgagor and Beneficiary represent that the proceeds of the Loan evidenced by the Note will be used for the purposes specified in 815 ILCS 205-4 of the Illinois Revised Statutes and that the principal sum evidenced by the Note constitutes a business loan which comes within the purview of such paragraph.
- 2.03 Neither Mortgagor nor Beneficiary, nor, to the best of Mortgagor's or Beneficiary's inswedge, any previous owner of the Property or any third party has used, generated, stored or disposed of roy Hazardous Substances on the Property. For the purposes of this representation and warranty, Hazardous Substances shall include, but shall not be limited to, any toxic or hazardous wastes, pollutants or substances, including, without limitation, asbestos, PCBs, petroleum products and by-products, substances defined or listed as hazardous substances or toxic substances or similarly identified in or pursuant to the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. á 9601 et seq., hazardous materials identified in or pursuant to the Hazardous Materials Transportation Act, 49 U.S.C. á 1802 et seq., hazardous wastes identified in or pursuant to The Resource Conservation and Recovery Act, 42 U.S.C. á 6901 et seq., any chemical substance or mixture regulated under the Toxic Substance Control Act of 1976, as amended, 15 U.S.C. á 2601 et seq., any toxic pollutant under the Clean Water Act, as amended, 33 U.S.C. á 1251 et seq., amy hazardous air pollutant under the Clean Air Act, 42 U.S.C. á 7401 et seq., and any hazardous or toxic substance or pollutant regulated under any other applicable federal, state or local environmental health or safety laws, regulations or rules of common law. Mortgagor and Beneficiary shall, jointly and severally, indemnify and hold

Mortgagee harmless from and against all liability, including all foresceable and unforesceable consequential damages, directly or indirectly arising out of the use, generation, storage or disposal of Hazardous Substances, including without limitation, the cost of any required or necessary repair, clean-up or detoxification and the preparation of any closure or other required plans, whether such action is required or necessary prior to or following transfer of title to the Property, to the full extent that such action is attributable, directly or indirectly, to the use, generation, storage or disposal of Hazardous Substances on the Property.

ARTICLE III WAIVER OF REDEMPTION

3.01 Each of Mortgagor and Beneficiary acknowledges that the Real Estate does not constitute agricultural real estate as said term is defined in Section 15-1201 of the Illinois Mortgage Foreclosure Law (the "Act") or residential real estate as defined in Section 15-1219 of the Act. Each of Mortgagor and Beneficiary hereby waives any and all rights of redemption under judgment of foreclosure of this Mortgage on behalf of Mortgagor or Peopliciary, and on behalf of each and every person acquiring any interest in or title to the Real Estate or of any necessary whatsoever subsequent to the date of this Mortgage. The foregoing waiver of right of redemption is made or small to the provisions of Section 15-160(B) of the Act. To the fullest extent permitted under applicable law, whiter Mortgagor nor Beneficiary shall apply for or avail itself of any appraisement, valuation, stay, extension or semption law, or so-called "Mortgagor under Laws," now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of this Mortgage, but each hereby waives the benefit of such laws. Each of Mortgagor and Beneficiary, for themselves and all who may claim through or under either of them, waives any and all right to have the Real Estate, and any estates comprising the Real Estate, marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Real Estate sold as an entirety.

MORTG FOR'S COVENANTS

- 4.01 Morigagor covenants and agrees to pay the Indebtedness and the other sums secured hereby in the manner and at the times provided for in the Loan Documents
- 4.02 Mortgagor and Beneficiary covenant and agree to pay, or cause to be paid, when due and payable by Mortgagor or Beneficiary:
 - (a) all real estate taxes, personal property taxes, assessment, license fees, water and sewer rates and charges, and all other governmental levies and charges, of every king and nature whatsoever, general and special, ordinary and extraordinary, unforeseen as well as foreseen, which shall be assessed, levied, confirmed, imposed or become a lien upon or against the Property or any contion thereof, and all taxes, assessments and charges upon the rents, issues, income or profits of the Property, or which shall become payable with respect thereto or with respect to the occupancy, use or possession of the Property, whether such taxes, assessments or charges are levied directly or indirectly (hereinafter collectively called the "Taxes"); and
 - (b) all other payments or charges required to be paid to comply with the terms and provisions of this Mortgage.

Within ten (10) days after written demand therefor, Mortgagor shall deliver to Mortgagee the original, or a photostatic copy, of the official receipt evidencing payment of Taxes or other proof of payment satisfactory to Mortgagee. Failure of Mortgagor to deliver to Mortgagee said receipts or to submit other proof satisfactory to Mortgagee as aforesaid shall constitute an Event of Default hereunder.

- 4.03 To assure payment of Taxes and insurance premiums payable with respect to the Property as and when the same shall become due and payable:
- (a) The Mortgagor shall deposit with Mortgagee at the time of the disbursement of the proceeds of the Note:

(i)An amount equal to one-twelfth of such Taxes due multiplied by the number of months elapsed (plus one additional month) between the date on which the most recent installment for such taxes was required to be paid and the date of such first deposit; and

(ii)An amount equal to one-twelfth of such annual insurance premiums multiplied by the number of months (plus one additional month) elapsed between the date premiums on each policy were last paid to and the date of such first deposit.

(b)Concurrently with each monthly payment installment pursuant to the Note, Mortgagor shall deposit with Mortgagee an amount equal to nine (9%) percent of the last ascertainable bills for Taxes and insurance premiums.

(c) The amount of such deposits ("Tax and Insurance Deposits") shall be based upon the most recently available bills therefor. All Tax and Insurance Deposits shall be held by the Mortgagee without any allowance of interest thereon.

(d)Monarly Tax and Insurance Deposits, together with monthly payments of principal, if any, and interest shall be paid in a ringle payment each month, to be applied to the following items in the following order:

(it ax and Insurance Deposits;

(ii)Indebteaness other than principal and interest on the Note;

(iii)interest on we Note;

(iv) Amortization of discipal balances of the Note.

(e)Mortgagee will pay insurance premiu as and Taxes from the Tax and Insurance Deposits upon the presentation by Mortgagor of bills therefor, or upon presentation of receipted bills, reimburse Mortgagor for such payments. If the total Tax and Insurance Deposits on hand are not sufficient to pay all of the Taxes and insurance premiums when due, Mortgagor will deposit with Mortgagee are mount necessary to make up the deficiency. If the total of such deposits exceeds the amount required to pay Takes and insurance premiums, such excess shall be credited on subsequent deposits to be made for such items.

(f)In the event of a default in any of the provisions of this Mor.gage or the Note, Mortgagee may, but shall not be required to, apply Tax and Insurance Deposits on any Indebreament, in such order and manner as Mortgagee may elect. When the Indebtedness has been fully paid, any remaining Tax and Insurance Deposits shall be paid to Mortgagor. All Tax and Insurance Deposits are hereby pledged as additional security for the Indebtedness and shall not be subject to the direction or control of the Mortgagor.

(g)Mortgagee shall not be liable for any failure to apply any amounts deposited to the payment of Taxes and insurance premiums unless while no default exists hereunder Mortgagor shall note presented to Mortgagee the appropriate Tax and insurance premium bills to be paid from the Tax and Insurance Deposits.

4.04 Mortgagor and Beneficiary covenant and agree to keep and maintain, or cause to keep and maintained, the Property (including all improvements thereon and the sidewalks, sewers, and curbs) in good order and condition and will make or cause to be made, as and when the same shall become necessary, all structural and nonstructural, ordinary and extraordinary, foreseen and unforeseen repairs and all maintenance necessary to that end. Furthermore, and without limiting the generality of the foregoing, neither Mortgagor nor Beneficiary will suffer any waste. All repairs and maintenance required of Mortgagor and Beneficiary shall be (in the reasonable opinion of Mortgagee) of first-class quality.

4.05 Mortgagor covenants and agrees that this Mortgage is and will be maintained as a valid mortgage lien on the Property and that Mortgagor will not, directly or indirectly, create or suffer or permit to be created, or to stand against the Property, or any portion thereof, or against the rents, issues and profits therefrom, any lien

(including any liens arising with respect to the payment of Taxes), security interest, encumbrance or charge whether prior to or subordinate to the lien of this Mortgage unless written approval is first obtained from Mortgagee. Mortgagor and Beneficiary will keep and maintain the Property free from all liens of persons supplying labor and materials for the construction, modification, repair or maintenance of any building or site improvement whether on the Property or not.

- 4.06 Mortgagor and Beneficiary covenant and agree, so long as the Indebtedness remains outstanding, to comply with all regulations, rules, ordinances, statutes, orders and decrees of any governmental authority or court applicable to Mortgagor or Beneficiary or applicable to the Property or any part thereof and to promptly cure any violation of law and comply with any order of any such governmental authority or court in respect of the repair, replacement or condition of the Property and any governmental regulations concerning environmental control and improvements.
- 4.07 Mortgagor covenants and agrees that all awards heretofore or hereafter made by any public or quasi-public authority to the present and all subsequent owners of the Property by virtue of an exercise of the right of eminent so nain by such authority, including any award for a taking of title, possession or right of access to a public way, or for any change of grade of streets affecting the Property, are hereby assigned to the Mortgagee.
- 4.08 Mortgagor and Beneficiary covenant and agree that neither the value of the Property nor the lien of this Mortgage will be diminished or impaired in any way by any act or omission of the Mortgagor or Beneficiary, and Mortgagor and Beneficiary agree they will not do or permit to be done to, in, upon or about said Property, or any part thereof, anything that may in any wise impair the value thereof, or weaken, diminish, or impair the security of this Mortgage.
- 4.09 Mortgagor covenants and agrees that if any action or proceeding is commenced in which Mortgagee in good faith deems it necessary to defend or up to the validity, enforceability or priority of the lien and interest of this Mortgage or to preserve the value of the security for this Mortgage, all sums paid by Mortgagee for the expense of any such litigation to prosecute or defend the rights, lien and security interest created by this Mortgage (including reasonable automeys' fees) shall be paid by Mortgagor, together with interest thereon at the rate then applicable under the Note and the Loan Agreement and any such sums and the interest thereon shall be a lien and security interest on the Property prior to any right or title to, wherest in or claim upon the Property attaching or accruing subsequent to the lien and security interest of this Mortgage, and shall be secured by this Mortgage.
- 4.10 Mortgagor and Beneficiary covenant to furnish from time to time within fifteen (15) days after Mortgagee's request, a written statement, duly acknowledged, of the a noune due upon this Mortgage, whether any alleged offsets or defenses exist against the Indebtedness and whether any defaults exist under the Loan Documents.
- 4.11 Mortgagor and Beneficiary covenant and agree to keep and maintain books and records of account, or cause books and records of account to be kept and maintained in which full, true and extrect entries shall be made of all dealings and transaction relative to the Property, which books and records of account shall, at reasonable times and on reasonable notice, be open to the inspection of Mortgagee and its account and other duly authorized representatives. Such books of record and account shall be kept and maintained either:
 - (a) in accordance with generally accepted accounting practices consistently applied; or
 - (b) in accordance with a cash basis or other recognized comprehensive basis of accounting consistently applied.

Mortgagor and Beneficiary covenant and agree to furnish or cause to be furnished to Mortgagee a report satisfactory to Mortgagee, including a balance sheet and supporting schedules and containing a detailed statement of income and expenses on the Property. Mortgagor and Beneficiary also covenants and agrees to furnish or cause to be furnished annually to Mortgagee an updated personal financial statement. Mortgagor and Beneficiary shall certify that each such report presents fairly Mortgagor's financial position. Mortgagor and Beneficiary further covenant and agree to furnish, or cause to be furnished, to Mortgagee annually on or before April 30th of each

year (or on or before August 30th of any year in which Mortgagor has elected an extension) copies of his federal income tax filings for the previous year.

If Mortgagor omits to prepare and deliver promptly any report required by this paragraph, Mortgagee may elect, in addition to exercising any remedy for an event of default as provided for in this Mortgage, to make an audit of all books and records of Mortgagor including his bank accounts which in any way pertain to the Property and to prepare the statement or statements which Mortgagor failed to procure and deliver. Such audit shall be made and such statement or statements shall be prepared by an independent Certified Public Accountant to be selected by Mortgagee. Mortgagor shall pay all expenses of the audit and other services, which expenses shall be secured hereby as additional indebtedness and shall be immediately due and payable with interest thereon at the rate of interest as set forth in the Note and shall be secured by this Mortgage.

ARTICLE V TRANSFER OR MORTGAGE OF PROPERTY

5.01 Mortgagor will not, without the prior written consent of Mortgagoe, further mortgage, grant a deed of trust, picare or otherwise dispose of or further encumber, whether by operation of law or otherwise, any or all of its interest in the Property. Beneficiary will not make and Mortgagor will not, and will not be required to, accept, and will not be bound by, any assignment of the beneficial interest in Mortgagor to any party except Mortgagoe. Mortgagor vill not, without the prior written consent of Mortgagoe, sell, assign, or transfer the Property or any interest therein. Any sale, assignment, transfer, mortgage, deed of trust, pledge, change or other disposition or encumbrance made it violation of the above provisions shall be null and void and of no force and effect and the making thereof shall constitute an Event of Default hereunder.

PERFORMANCE OF MORTGAGOR'S OBLIGATIONS

Upon the occurrence of an Event of Default under this Mortgage, then, without limiting the generality of any other provision of this Mortgage, and without waiving or releasing Mortgagor or Beneficiary from any of their obligations hereunder. Mortgagee shall nave the right, but shall be under no obligation, to pay any Impositions or other payment, or any sums due under this Mortgage, and may perform any other act or take such action as may be appropriate to cause such other term, coverent, condition or obligation to be promptly performed or observed on behalf of Mortgagor or Beneficiary.
