MEMORANDUM OF LEASE

This Memorandum of Lease is made as of the <u>Intermediate</u> day of May 1998, between THE MASSIVE COMPANY, L.L.C., with an address at 222 North LaSalle Street, Chicago, Illinois (hereinafter referred to as "Landlord"), and PERSPECTIVES CHARTER SCHOOL, an Illinois not-for-profit corporation with its principal office at 1532 South Michigan Avenue, Chicago, Illinois (hereinafter referred to as "Tenant").

Candlord's predecessor

Landlord and Tenant have entered into a Lease (the "Lease") dated as a August ____, 1997, whereby Landlord has leased to Tenant a portion of the real property (the "Property"), in City of Chicago, Cook County, Illinois, the legal description of which Property is set forth on Exhibit "A" attached hereto. The Lease contains provisions and rights appurtenant to the Property, some of which are as follows:

- 1. Term. The term of the Lease is for a period of fifty-eight months, commencing on September 1, 1997.
- 2. <u>Successors</u>. The covenants, conditions and agreements made and entered into by the parties include shall be binding upon and inure to the benefit of their respective heirs, administrators, executors, representatives, successors and assigns.
- Incorporation of Lease. All the terms and conditions of the Lease are hereby incorporated herein by reference as if fully set forth herein. This Memorandum of Lease is solely for notice and recording purposes and shall not be construed to alter, modify, expand, diminish or supplement the provisions of the Lease. In the event of any inconsistency between the provisions of this Memorandum of Lease and the provisions of the Lease, the provisions of the Lease shall govern.
