



#### 3. Legal Description:

Unit T-17-D in the Triumvera Townhome Condominium, as delineated on the Survey of certain parcels of real astate in the South half of the Southeast Quarter of Section 32, Township 42 North, Range 12 East of the Third Principal Maridian in Cook County, Illinois described in said Survey as Parcels T-7, T-8, T-9, T-10, T-11, T-12, T-13, T-14, T-15, T-16, and T-17, thereinafter referred to as the Parcels), which Survey is attached as Exxhibit "C" to the Declaration of Condominium Ownership for the Triumvers Townhome Condominium made by LaSalle National Bank, a National Banking Association, as Trustee under Trust Agreement dated November 1, 1972 and known as Trust 44885 and by Birnloew Development Corporation, a corporation of Illinois, filed in the Office of Registrar of Titles of Cook County, Illinois as Document No. LR 2806521, as amended from time to time, including the Amendment to waid Survey ectached as Exhibit "C" to Amendatory and Supplemental Declaration mada by said Trustee and by Triumvera, a corporation of Illinois, filed as aforesaid as Document No. LR 3042318, togrther with said Unit's undivided percentage interest in the Parcels (excepting from said Parcels all the property and space comprising all the units thereof as defined and set forth in said Declaration, Survey and Amendments thereto.)

Parcel 2: Easements for ingress and squess appurtenant to and for the benefit of Parcel 1 as set forth in the Declaration of Covenants and Restrictions and Basements for the Triumvers Homeowner's Association filed as Document No. LR 2754081, as amended from time to time.

Grantor hereby grants grantees, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration for the Triumvers Townhome Condominium and in the aforementioned Declaration for the Triumvers Homeowner's Apociation, and in all amendments to said respective Declarations, and grantor reserves to itself, its successors and assigns, the rights and easements set forth in said respective Declarations and amendments for the benefit of the remaining property discribed in said respective Declarations. Any deed is conveyed on the conditional limitation that the percentage of ownership of said grantees in the common elements shall be divested pro tanto and vest in the grantees of the other units in accordance with the terms of said Declaration and any amended declarations filed pursuant thereto, and the right of revocation is also hereby reserved to the grantor herein to accomplish this result, the acceptance of this conveyance by the grantees shall be deemed an agreement within the contemplation of the Condominum Property Act of the State of Illinois to a shifting of the common elements pursuant to said Declaration and to all the other terms of said Declaration, which is hereby incorporated herein by reference thereto, and to all the terms of each amended Declaration filed pursuant thereto.
