TOGETHER with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances and rents all of which shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are hereinafter referred to as the "Property."

Lender prior to acceleration shall give besice to Borrower as provided in paragraph 12 hereof specifying: (1) the breach; (2) the action required to cure such breach; (3) a date, not less than 10 days from the date the notice is mailed to Borrower, by which such breach must be cored; and (4) that failure to cure such breach on or before the date specified in the notice may result in acceleration of the surfix recured by this Mortgage, foreclosure by judicial proceeding, and sale of the Property. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the nonexistence of a default or any other defense of Borrower to acceleration and foreclosure. If the breach is not cured on or before the date specified in the notice, Lender, at Lender's option, may declare all of the sums secured by this Mortgage to be narrediately due and payable without further demand and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorneys fees and costs of documentary evidence, abstracts and title reports.

18. Borrower's Right to Reinstate. Notwithstanding Lender's accordination of the sums secured by this Mortgage due to Borrower's breach, Borrower shall have the right to have any proceedings breun by Lender to enforce this Mortgage discontinued at any time prior to entry of a judgment enforcing this Mortgage (2014) Borrower pays Lender all sums which would be then due under this Mortgage and the Note had no acceleration occurred; by Portower cures all breaches of any other covenants or agreements of Borrower contained in this Mortgage; (c) Borrower pays all a asonable expenses incurred by Lender in enforcing the covenants and agreements of Borrower contained in this Mortgage, and in enforcing Lender's remedies as provided in paragraph 17 hereof, including, but not limited to, reasonable attorneys' fees; and (d) Degrower takes such action as Lender may reasonably require to assure that the lien of this Mortgage.
