On information and belief, on or before December 15, 1997 MICHAELS was the contractor for COLE TAYLOR, AMOCO, and McDONALD'S for the construction and/or improvement of the Property.

On or before December 15, 1997, MICHAELS made a contract with DIFOGGIO, as a subcontractor, to furnish and supply labor and materials for the installation of hydraulic and other piping ("labor and materials") on the Property for the construction and/or improvement of the Property.

The value of the labor and materials provided to the Property by DIFOGGIO at the specific request of MiCHAELS totals the sum of SEVENTY FOUR THOUSAND THREE HUNDRED SEVENTY SEVEN and 50/100 (\$74,377.50) Dollars. The labor and materials provided by DIFOGGIO have been incorporated into and have become a fixed part of the Property.


