AGREED JUDGEMENT ORDER

THIS MATTER COMING ON TO BE HEARD upon the Complaint of the CITY OF CHICAGO, a municipal corporation, for the ascertainment of just compensation to be paid for the taking by said Plaintiff, for the uses and purposes in its Complaint mentioned and set forth, of the property described therein, being Parcel 123; the said Compaint to Condemn having been heretofore filed on December 9, 1997 and the Plaintiff, the CITY OF CHICAGO, a municipal corporation, appearing by: BRIAN L. the sum of SEVETY THOUSAND FIVE HUNDRED TWENTY DOLLARS AND 00/100 (\$70,520.00) as full compensation for the taking of the fee simple title thereto.

IT IS THEREFORE ORDERED AND ADJUDGED by the Court that the Plaintiff, within ninety (90) days from the entry of this Order, pay to the County Treasurer of Cook County, Illinois, for the benefit of the Owner or Owners of Parcel 123 the sum of SEVENTY THOUSAND FIVE HUNDRED TWENTY DOLLARS AND 00/100 (\$70,520.00) as full compensation for the taking of said parcel aforesaid, with the statutory interest payable thereon, plus \$104 court costs, for the uses and purposes set forth in its Complaint herein. The Defendant shall file a Petition to Withdraw in this Court according to his rights in the award.

IT IS THEREFORE ORDERED AND ADJUDGED that I pon payment as aforesaid, the Plaintiff herein shall be thereby vested with the fee simple absolutable to said Parcel of real property paid for by Plaintiff as aforesaid; and that full physical possession shall be surrendered by the Defendant to said Plaintiff, the CITY OF CHICAGO, immediately upon the vacation of the Parcel by the Defendant, which vacation shall occur no later than June 30, 1998, whereupon the Plaintiff shall be authorized and empowered to emer upon and take possession of said real property so paid for. Defendant shall deliver the Parcel ir. a condition consistent with the terms set forth in the Stipulation for Judgment Order entered into by the parties hereto.

IT IS FURTHER ORDERED AND ADJUDGED that this Court retain jurisdiction of this Cause for the purpose of awarding Plaintiff Writ or Writs of Assistance to put Plaintiff, the CITY OF CHICAGO, in possession of the Parcel of real property with respect to which Plaintiff has acquired the fee simple absolute title and rights of possession, as aforesaid.
