The buildings and improvements shall be so restored or rebuilt as to be of at least equal value and substantially the name character as prior to such damage or destruction. In the event Mortgagor is entitled to reimbursement out of insularize proceeds, or, if Mortgagee elects to permit reimbursement out of insurance proceeds, such proceeds shall be made averable.
