EASEMENT MAINTENANCE AGREEMENT

WHEREAS, a Plat of Subdivision was recorded on March 24, 1998, for the following ribed property (hereins from referred to as "Property"):


and commonly known as 3265, 3275 and 3285 Potter Road, Northbrook, Illinois 60062; and

WHEREAS, said Plat of Subdivision provided for a ten foot easement for storm sewer along the west end of the Property, a five foot easement for storm sewer along the north end of Lot 3, a five foot easement for storm sewer along the courth end of Lot 2, and a thirty-eight foot easement for drainage and detention along the east end of the Property (hereinafter referred to as "Easement Areas"); and

WHEREAS, said Plat of Subdivision provided that the easements were to be privately maintained by the owners of the Property, their successors and assigns.

NOW THEREFORE BE IT AGREED by the owners of the above described Property, that the owners of Lots 1, 2 and 3 shall each be responsible for one-third of the cost of any maintenance or repairs needed to the Easement Areas.

In the event any owner(s) shall fail to pay its respective share, the non-defaulting owner(s) shall have the right, but not the obligation, to pay the defaulting owner's portion and place a lien on the property of the defaulting owner(s). Such lien may be enforced by the non-defaulting owner(s), who may also recover all reasonable costs and attorneys' fees incurred, in the manner provided by law for enforcement and foreclosure of liens.
