TENANTS BY THE ENTIRETY forever.

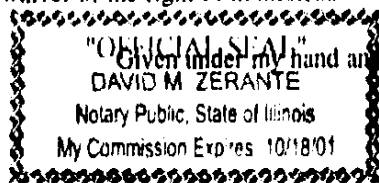
