MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE IS DATED APRIL 16, 1998, BETWEEN USHA R. SHARMA and VANDANA SHARMA, as joint tenants, (referred to below as "Grantor"), whose address is 5553 S. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
