PARTIAL RELEASE DEED

unto Deer Crossing II Limited Partnership, A Delaware Limited Partnership, and His/Her/Their heirs, successors, legal representatives and assigns, whatever right, title, interest, claim or demand the Bank may have acquired in, through or by said Mortgage and the other described instruments to the said property.
