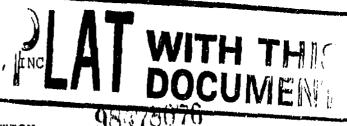

WHEREAS, by the Declaration of Condominium Ownership recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 98085725 on February 2, 1978.
FIRST NATIONAL BANK OF EVERGREEN FARK as Trustee, under Trust Number 12018, dated DECEMBER 3, 1992, and not individually, submitted certain real estate to the Condominium Property Act of the State of Illinois (the "Act"), said Condominium being known as CHAPEL HILLS CONDOMINIUMS; and

WHEREAS, under Paragraph 1 of ARTICLE XIX of the Declaration, the right is reserved in the Developer, P.D. hAPTZ CONSTRUCTION CO. INC., to annex and add certain real property to the Parcel and Property described in the Declaration, and thereby add to the Condominium; and

WHEREAS, FIRST NATIONAL BANK OF EVERGREEN PARK, is trusted under Trust Agreement dated DECEMBER 3, 1992, and known as Trust No. 12818 in the legal title holder of the property to be arnexed and P.D. HARTZ CONSTRUCTION CO., INC. is the Developer and beneficial owner of said Trust and wishes to so annex and add to said Parcel and Property, and thereby submit to the Act as a part of the Condominium the following real property ( the "Additional Property"):

WHEREAS, the Additional Property is now improved with one (1) building containing four (4) units, making a total of four (4) additional units, as defined in the Declaration.

NOW THEREFORE, FIRST NATIONAL BANK OF EVERGREEN PARK, as Trustee under Trust Agreement dated December 3, 1992, and known as Trust No. 12818 and not individually, as the legal title holder of the Additional Fromerty and P.D. HARTZ CONSTRUCTION CO., INC. as the beneficial owner of said Trust, and for the purpose above set forth, hereby declares that the Declaration be and hereby is amended as follows:

- The Additional Property is hereby annexed to the Parcel and Property as defined in Drticle I of the Declaration and is hereby submitted to the provisions of the Act as a part of the Condominium in accordance with, and shall be deemed to be governed in all respects by the terms and provisions of the Declaration.
- The Plat attached to the Declaration as Exhibit "A" showing the boundaries of the Property and delineating and describing the Units contained therein, is hereby amended and supplemented by Exhibit "A" attached herete showing the boundaries of the annexed Property and Describing the additional units contained in said annexed Property.
- Exhibit "B" attached to the Declaration secting forth the percentages of the undivided interest in the common elements CD corresponding to each Unit described in Exhibit "A" prior to this 12 Amendment are hereby reduced to the respective percentage interest in the common elements as set forth in Exhibit "B" attached hereto. Exhibit "B" attached to the Declaration is amended to the substitution of Exhibit "B" attached hereto.
- The additional common elements added to the Declaration by this Amendment, are hereby granted and conveyed, all as set forth in the Declaration.
- Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
