FIFTH AMENDMENT TO ASSIGNMENT OF LEASES AND RENTS

WHEREAS, on the 10th day of April, 1991, PETULA ASSOCIATES, LTD., an Iowa corporation, and NARCO ENTERPRISES, INC., an Illinois corporation, formerly known as Narco Properties, Ltd., an Illinois corporation (hereinafter collectively referred to as "Borrower"), executed and delivered to PRINCIPAL MUTUAL LIFE INSURANCE COMPANY, an Iowa corporation ("Lender"), a Secured Promissory Note ("Note") in the total amount of Seven Million Four Hundred Ninety Thousand and 00/100 Dollars (\$7,490,000.00), with interest thereon as set forth in said Note. Said Note was and is secured by a Mortgage and Security Agreement ("Mortgage") dated April 10, 1991, and an Assignment of Leases and Rents, dated April 10, 1991, duly signed and acknowledged by Borrower; said Mortgage being recorded on April 24, 1991, as Instrument No. 91189599 of the Official Records of Cook County, Illinois, and said Assignment of Leases and Rents was recorded on April 24, 1991 as Instrument No. 91189600 of the Official Records of Cook County, Illinois, said Mortgage and Assignment of Leases and Rents covering real property more particularly described in Exhibit "A" attached to the original recorded Deed of Trust and Assignment of Leases and Rents; and

WHEREAS, said Note was amended on June 13, 1996, January 10, 1997, July 10, 1997 and on November 18, 1997, to reflect a change in the maturity date of said Note and to reflect certain changes and modifications made to said Note. Said Mortgage was amended on June 13, 1996, January 10, 1997, July 10, 1997, and on November 18, 1997, and said amendments were recorded on July 24, 1997, January 29, 1997, July 31, 1997 and on December 1, 1997, respectively, as Instrument No. 96563707, as Instrument No. 97065794, as Instrument No. 97555281 and as Instrument No. 97895552, respectively, Official Records of Cook County, Illinois. NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, it is agreed by parties hereto that the aforesaid Assignment of Leases and Rents dated April 10, 1991, as previously amended, should be modified and further amended as follows:

1. In the fourth line of the second paragraph on page one, delete "May 1, 1998" and insert therein "January 1, 1999".
2. Borrower hereby represents that the Premises are free and clear of any liens, privileges, mortgages or encumbrances except as expressly permitted in the Mortgage executed by Borrower and dated the same date as the Note.

It is agreed by the parties hereto that all of the terms, covenants, conditions and warranties contained in the above-described Assignment of Leases and Rents, dated April 10, 1991, as previously amended, which are not changed, modified or amended by this instrument are unchanged and are hereby ratified, affirmed and held to be in full force and effect.

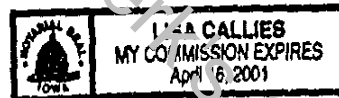

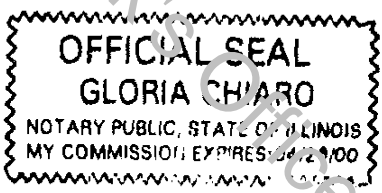
