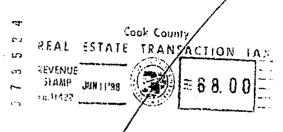

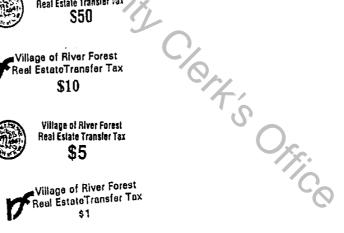


Village of River Format Real Estate Transfer Tax **S50**

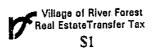




Village of River Forest Real Estate Transfer Tax \$5
