respectively, to the premises therein described, situated in the County of Cook, State of Illinois as follows, to wit:



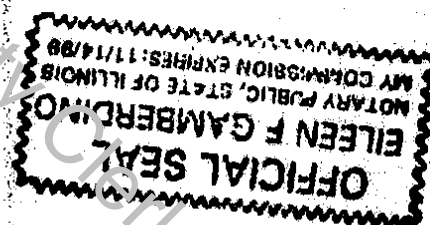
