LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into as of May 27, 1998, but made effective as of June 1, 1998, by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, an Illinois corporation ("BANK") & DONALD LINK and KAROL KADECHKA, husband and wife, ("BORROWER")

WHEREAS:

- The BORROWER has heretofore executed a Promissory Note dated **August 28, 1997**, in the principal amount of \$292,800,00 ("NOTE"), of which the BANK is presently the holder;
- The NOTE is secured by a Mortgage, Assignment of Rents & Security Agreement (Chattel Mortgage) dated August 28, 1997, and recorded in the Recorder's Office of Cook County, Illinois, as document number 97667573 ("MORTGAGE"), placing a mortgage lien on certain real estate described in Exhibit "A" attached hereto and by this reference incorporated herein ("REALES" ATE").
- The BANK has made available to BORROWER the sum of \$292,80%,00, which amount represents the entire principal sum of the indebtedness evidenced by the NOTE, on which there is a current outstanding principal balance of \$210,160.00;
- The interest rate evidenced on said NOTE is 1.5% ("the margin") over the Prime Rate of interest per annum. For purposes of this loan the "Prime Rate" shall mean the prime rate of interest as amboniced by Lender from time to time.
- 5 The maturity date evidenced on said NOTE is May 4, 1998.
- The BORROWER desires to amend the interest rate, repayment terms and maturity date as evidenced by the NOTE.
- The BANK has agreed to such modification pursuant to the terms and conditions of a commitment of the BANK dated May 26, 1998 ("COMMITMENT").

NOW THEREFORE, notwithstanding anything contained in the NOTE and MORTGAGE, and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

A The principal amount evidenced by the NOTE as of the effective date is \$292,800.00

- The interest rate evidenced by the NOTE as of the effective date is 8.25% per annum.
- Principal and interest payments in the amount of \$2,308.58 (based on a 25 year amortization) shall be due and payable monthly beginning July 1, 1998, and on that day each month thereafter until all of said outstanding principal plus any remaining accrued interest and late charges, if any, are repaid in full.
- D The maturity date is hereby amended to June 1, 2003.
- Except as modified herein, the terms, covenants and conditions of the MORTGAGE shall remain unchanged and otherwise in full force and effect. In the event of any inconsistency between the terms of this agreement and the terms of the NOTE and/or MORTGAGE, the terms herein shall control
- The lien of the MORTGAGE IS hereby modified as security for the payment of the principal sum evidenced by the NOTE and amended by this MODIFICATION AGREEMENT
- This agreement shall be governed by and construed under the laws of the State of Illinois.
