REAL ESTATE

PARCEL 1

PARCEL 2

That part of the North East fractional quarter of Section 21, Township 39 North, Range 14, East of the Third Principal Meridian, being a strip of land 7 feet 2 inches wide West of and adjoining to lots 43, 44, 45 of Wilders South Addition to Chicago in the East fraction of the North East fractional quarter of Section 21, Township 39 North, Range 14, East of the Third Principal Meridian, lying South of a line 9.7 feet South of and parallel to the North line of said lot 43 extended West, excepting therefrom a triangular piece (measuring approximately 1.3 feet on the West line) in the North West corner of said strip conveyed by the Quaker Oats Company to the Illinois Central Railroad Company, the Chicago Burlington and Quincy Railroad Company, the Chicago and Northwestern Railway Company, and the Michigan Central Railroad Company, by deed dated August 7, 1915 and recorded August 27, 1915 in recorder's office of Cook County, Illinois, as Document 5599348.

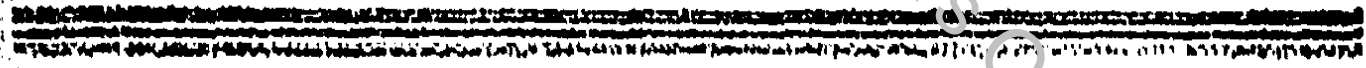
PARCEL 4

Lot 13 (except the North 5 feet thereof), Lots 14, 15, 16, 17 and Lot 18 (except the North 5 feet thereof) in Wilder's South Addition to Chicago in Section 21, Township 30 North, Range 14 East of the Third Principal Meridian in Cook County, Illinois.

PARCEL 6

That certain strip of land lying between Lots 13 to 18 aforesaid described as follows: Commencing at the South East corner of said Lot 16; running thence North along the East line of said Lots 16, 17 and 18 to the North East corner of said Lot 18; thence East to the North West corner of Lot 13; thence South along the West line of Lots 13, 14 and 15 to 16th Street; thence West along the North line of 16th Street to the place of beginning (except therefrom the North 5 feet); said strip was formerly a public alley but was vacated by an order of the Common Council of the City of Chicago by unanimous vote of April 22, 1870, all in Wilder's South Addition to Chicago, in Section 21, Township 30 North, Range 14 East of the Third Principal Meridian in Cook County, Illinois.
