MORTGAGE

THIS MORTGAGE IS DATED JUNE 24, 1998, between BANK OF HOMEWOOD AS T/U/T NO. 98027, AND NOT INDIVIDUALLY, whose address is 2034 RIGIE ROAD, HOMEWOOD, iL 60430 (referred to below as "Grantor"); and Bank of Homewood, whose aduress is 2034 Ridge Road, Homewood, IL 60430 (referred to below as "Lender").

GRANT OF MORTGAGE. Indebtedness. Addresses. The mailing addresses of Brantor (debtor) and Lender (secured party), from which information concerning the security interest granted by this Mortgage may be obtained (each as required by the Uniform Commercial Code), are as stated on the first page of this Mortgage.

FURTHER ASSURANCES; ATTORNEY-IN-FACT. The following provisions relating to further assurances and attorney-in-fact are a part of this Mortgage.

Further Assurances. False Statements. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor or Borrower under this Mortgage, the Note or the Related Documents is false or misleading in any material respect, either now or at the time made or furnished.

Defective Collateralization. This Mortgage or any of the Related Documents ceases to be in full force and effect (including failure of any collateral documents to create a valid and perfected security interest or lien) at any time and for any reason.

Insolvency. Mortgagee in Possession.
