TERMINATION AGREEMENT

THIS TERMINATION AGREEMENT (this "Agreement") is made as of the _____ day of June, 1998 by and between DOESON LEASING CO., an Illinois corporation ("Landlord"), and BOTTLEWERKS MOLDING, INC., a Illinois corporation ("Tenant").

WITNESSETH

- A. Tenant hereby certifies, with respect to Tenant's rights in and occupancy of the Premises, that the following statements are true as of the date hereof and will be true on the Termination Date:
 - (a) Turint owns and holds the entire interest of Tenant under the Lease:
 - (b) There exist no subleases made by Tenant affecting the Premises or any part thereof, and Tenant has not granted to any other person any rights to use, occupy or possess the Premises;
 - (c) Tenant has not assigned, trunsferred or encumbered Tenant's interest under the Lease or any part thereof;
 - (d) No contracts for the furnishing of any labor or materials with respect to improvements or alterations in or about the Premises have been let by Tenant and are outstanding that have not been performed and satisfied; and
 - (e) Tenant has full authority to execute and deliver this Agreement.
