MODIFICATION OF TRUST DEED

PRUST AS TRUSTEE ("TRUSTEE"), WHICH TRUST DEED WAS RECORDED IN THE OFFICE OF THE RECORDER OF DEEDS OF COOK COUNTY, ILLINOIS ON SEPTEMBER 20, 1994 AS DOCUMENT NUMBER 94-817606 AND RELATES TO THE PROPERTY LEGALLY DESCRIBED ON EXPUBIT A ATTACHED HERETO AND MADE A PART HEREOF.

WHEREAS, First Party and Trustee have agreed to amend the Trust Deed as hereinafter set forth.

NOW, THEREFORE, First Party and Trustee agree that the Trust Deed is hereny amended as follows:

(a) Page 1 of the Trust Deed is hereby amended by inserting the following region immediately following the first recital on said Page 1:
