To evidence the election by the Borrower of the Conditional Right to Refinance as provided in the Balloon Note Addendum and Balloon Rider and to modify the terms of the Note and Security Instrument in accordance with such election, Borrower and Lender agree as follows (notwithstanding anything to contrary contained in the Note or Security Instrument):

- 1. The Borrower is the owner and occupies the Property.
- 2. As of July 1, 1998 the amount payable under the Note and Security Instrument (the "Unpaid Principal Balance") is U.S. \$171,066.53.
- 3. The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at yearly rate of 7.625%, beginning July 1, 1998. The Borrower promises to make monthly payments principal and interest of U.S. \$ 1278.11, beginning on the 1st day of August 1, 1998 and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full. If on July 1, 2023 (the "Modified Maturity Date"), the Borrower still owes amounts under the Note and the Security Instrument, as amended by this Modification, the Borrower will pay these amounts in full on the Modified Maturity Date.

The Borrower will make such payments at <u>Banc One Mortgage Corporation</u>, P.O. Box 7700, Indianapolis, IN 46277 or at such other place as the Lender may require.
